viaSport leads the development and growth of amateur sport in BC by working closely with the Ministry of Tourism, Arts, Culture and Sport to steward the provincial government's investment in amateur sport. We work directly with Designated Sport Organizations in BC to build a stronger, more effective sport system; we work collaboratively with all interest holders to build public trust and increase confidence in amateur sport.
